Chapter: 1 | Overview

1.1 Official Secretary's Review



The year 2015 will be recorded as another historic period for Fiji: it saw His Excellency Brigadier-General (Ret'd) Ratu Epeli Nailatikau successfully completing histenure as President and Head of State, a position he held since 2009, and the inauguration of His

Excellency Major-General (Ret'd) Jioji Konusi Konrote as Fiji's fifth Head of State since becoming a Republic in 1987.

The smooth transition under Fiji's new Constitution, that His Excellency Ratu Epeli Nailatikau assented to in 2013, reflected Fiji's maturity as an independent and sovereign nation. His Excellency Ratu Epeli Nailatikau was farewelled on 11 November by hundreds of local and foreign dignitaries at the Coronation Ground of the State House. His Excellency Major-General (Ret'd) Jioji Konrote was inaugurated on 12 November, at the same venue.

The 2015 Annual Report is dedicated to the former President, His Excellency Ratu Epeli Nailatikau. On pages 20 and 21, we provide a summary of His Excellency's record-breaking engagements. In essence, His Excellency achieved a number of firsts during his tenure ranging from being the first Head of State in Fiji to champion a particular cause and to assertively pursue the cause to the greatest extent possible - for instance visiting virtually all the secondary schools in Fiji and personally interacting with over 71,000 students; to developing an unprecedented high work rate including attending almost 350 engagements and delivering 180 speeches in a calendar year. At one particular engagement overseas involving His Excellency's role as Fiji's Special Representative on HIV/AIDS, His Excellency delivered 12 speeches within eight days.

The exceptionally high work rate reflected His Excellency's philosophy to "always lead by example." Even after leaving Office, His Excellency continues to serve the nation and the international community in his capacity as the United Nation's Goodwill Ambassador on HIV/AIDS for the Pacific.

The Report also describes the other major achievements of the Office including facilitating the new President's equally high work rate. At the time of writing this Report, His Excellency had attended to an average of 17 engagements including delivering about five speeches per month - indications of how His Excellency wishes to continue the trend set by his predecessor.

At the operational level, the Office channeled significant effort to developing its human resources through increased and ongoing training throughout the year. It also channeled attention to improving its financial management capabilities. At the time of writing this Report, the Office was able to clear all the outstanding accounts that had accumulated from the past nine years. It also had put in place more stringent measures including risk management strategies to ensure that the Office is able to lead by example through its facilitation of the President and Head of State's exceptionally high work rate while strengthening its governance systems with a focus on accountability and transparency.

I acknowledge the increasing support towards the Office of the President from across the whole of Government in particular the Office of the Prime Minister for the constant guidance on issues of national and international significance, and the Ministry of Economy for easily facilitating the funding needs of the Office. The contribution of all the staff members is also acknowledged with appreciation.

1.2 Office Overview

- The Official Secretary, in his capacity as the operational Head for the Office of the President oversees the three divisions namely; the Executive Support Division, the Operations Division and the Corporate Services Division. The Security Services Division is under the charge of the President's Aide-de-Camp.
- The Executive Division provides direct support to the President by planning, organising and managing all national and international engagements; advising on contextual matters and other issues; and drafting speeches and messages. The division also responds to all communication from stakeholders and the public at large.
- The Operation Division handles all support services within the Domestic Services Section, which deals directly with His Excellency's personal welfare and wellbeing; and the Landscape Section with all its activities, including the upkeep of the State House compound and the outposts. The third unit that comes under this division is the Project Management Unit (PMU), which manages all capital projects for the Office.
- The Corporate Services Division provides corporate services, Finance, Human Resources Management, and

Information Technology support for the Office. The division also manages and coordinates transport and the College of Honour Section.

1.3 2016 Outlook

- The Office will continuously re-align itself to improve the support services towards the new President's first term in Office, placing emphasis on continued improvement of services to the national and international community as per requirements of the Constitution and protocol.
- The Office will continue to facilitate the President's social obligations and support areas of special concern to His Excellency.
- The Office will seek to ensure that more deserving citizens are awarded under the Honours and Awards System.
- The organisational reform in-line with Government's overarching civil service reform agenda will continue to be addressed by the management of the Office. This includes continuing the focus on human resources development, improving its financial management capabilities, and securing and allocating appropriate resources for capital projects.

2.1 Vision:

To Be the Pillar of National Unity

2.2 Mission:

The primary mission of the Office of the President is:

- To support the President in fulfilling his obligations as the Executive Authority of the State. The Office of the President will work in accordance with all relevant legislations including the Constitution and the Honours and Awards Act 1995, among others;
- To provide outstanding facilitative services to its customers including all members of the public and both local and foreign dignitaries;
- To emphasise the importance of its human resources and accommodate their creative and innovative abilities in the pursuit of service excellence; and
- To operate within its budget and allocated resources whilst investing in technology to improve the efficiency and effectiveness of service delivery.

2.3 Values:

The Office of the President shall uphold the core of intrinsic values consistent with the values espoused by the Public Service as articulated in the Constitution.

The values and principles of State Service include:

- High standard of professionalism, including ethics and integrity;
- Prompt and faithful implementation of Government policies and administration of laws;
- Being free from corruption;
- Efficient, effective and economic use of public resources; prompt response to requests and questions and delivery of service to the public in a respectful, effective, impartial, fair and equitable manner;
- Accountability for administrative conduct;
- Transparency including:
- Timely, accurate disclosure on information to the public;
- Prompt, complete and candid reporting to Parliament as required by law;

- Cultivation of good human resource management and career development practices, to maximise human potential; and
- Recruitment and promotion based on objectivity, impartiality and fair competition, ability, education, experience and other characteristics of merit.

- The People's Charter for Change, Peace and Progress

2.5 Roles and Responsibilities

Accordingly, the role and responsibilities of the Office of the President are specifically:

- To ensure that the responsibilities of the President under the Constitution and other relevant Legislations are carried out effectively and efficiently;
- To facilitate the proper administration of the Office including the effective utilisation of the budgetary provision in accordance with Public Service Rules and Regulations and the Financial Regulations, respectively;
- To provide domestic support services to His Excellency the President, including the proper care and maintenance of all the Presidential properties;
- To provide secretariat support services in the administration of the Fiji Honours and Awards system, and;
- To provide security and personal protection services to the President and his immediate family through the Republic of Fiji Military Forces and Fiji Police.



Security Brief

Security is provided for 24 hours to the President and his immediate family. This is provided by the Republic of Fiji Military Forces and the Fiji Police Force. The Security Protection Unit accompanied the President to all functions held outside the State House including trips abroad.

A new Aide-de-Camp, Captain Ilai Tawakedrau replaced Captain Iferemi Sakumeni, who left for further studies.

3.2 Strengthen Accountability and Reforms

I. Landscape Services

Services include the provision of maintenance and up-keep of the State House compound and the Presidential properties at Deuba and Lautoka. These services are provided by the Landscape Section, and this year the following work was carried out by the Section:

- Maintenance of the perimeter walls and the uncompleted sewerage lines laying project.
- Cleanliness and beautification of the various properties including road markings and flower plot preparations and planting.

- Promotion of environmental sustainability through proper disposal of office equipment, non-green wastes, etc.
- Promotion of organic gardening through the development of a compost site.
- Participation in community work towards environment cleanliness.
- Facilitate renovation to the accounts office.
- Maintenance work at the State House including fixing showers and bathrooms.
- Installation of a new automatic change-over switch for FEA and generator power supply and vice-versa.
- Small maintenance work including repairing the back gate hinges and plumbing at the State House.

II. Domestic Services

Services include the provision of professional domestic support and the procurement of soft furnishings for the State House.

Services provided in 2015 included:

- Attendance to deliverables in the provision of daily support services to the President and family.
- Attendance to state functions for domestic and catering services.
- Facilitating meetings held at the State House or at the Official Office.
- Facilitating catering needs for the President during his travels.
- Preparation and set-up of the State House including flower arrangements.

III. Formulation of A Master Plan

Birthing Stages – Meetings were held with stakeholders including the Thurston Gardens Master Plan Committee to prepare for an Office Master Plan. Initiation Stage included gathering information on the history of the Government House and accessing a topographical survey of the Presidential compound from the Ministry of Lands.



Outstanding Achievements

- Began advocacy as Fiji's Special Representative on HIV/AIDS in 2010. His Excellency visited virtually all the secondary schools in Fiji to create greater awareness for HIV/AIDS in 2015. He began his school visits in 2012 through to 2015, becoming the only Fiji President to visit all except one secondary school and spoke to over 71, 000 students.
- 2012: Visited 25 schools reaching 15,704
- 2013: Visited 96 schools reaching 40,998
- 2014: Visited 31 schools reaching 10,241
- 2015: Visited 22 schools reaching 4,337
- Assented the 2013 Constitution of the Republic of Fiji on Friday 6 September, 2013.
- His Excellency embarked on official visits to selected Pacific Island countries in 2013 through to 2014. In total, His Excellency visited 11 countries altogether, making it a first for a Fiji President to officially visit neighbouring Pacific Island States.
- His Excellency met a number of Heads of States and Governments including the President of Singapore, His Excellency Tony Tan in 2012; President of Kiribati, His Excellency Anote Tong, in 2013; the President of Indonesia, His Excellency Susilo Bambang Yudhoyono in 2014; the President of the People's Republic of China, His Excellency Xi Jinping in 2014; and the Prime Minister of India, Honourable Narendra Modi in 2014.
- Patron to almost 20 organisations.
- Officiated in the swearing-in of the Prime Minister and both Cabinet and Assistant Ministers in 2014.
- Awarded the Knight of Grace of the Most Venerable Order of the Hospital of St. John of Jerusalem (KSt. J) by Her Majesty the Queen Elizabeth II, the Sovereign Head of the Order of St. John and personally conferred by the Lord Prior of the Order of St. John, Professor Anthony Mellows in Suva in January 2014.
- In the weeks leading up to Christmas, His Excellency made annual visits to various hospitals, correction centres and homes around the country. In 2013, he visited 13 Hospitals, 5 Corrections centres and 4 Homes and again in 2014, he visited 14 Hospitals, the 4 Corrections centres and 4 Homes.



As Patron of the Fiji Children's Awards, His Excellency recognised a selected number of students in November 2012 for their contribution towards improving the lives of others.

- 1926 Construction of a new building by Whan Construction Co. Ltd commenced
- 1928 Construction of Government House was completed
- The cost of the construction was £25,000 which would be millions in today's currency
- The first Governor to occupy Government House was Sir Cecil Hutson in 1982
- The old House was originally surrounded by a lush tropical forest which has been replaced by the present spacious lawns and gardens
- Her Majesty Queen Elizabeth II, the Duke of Edinburgh, other members of the royal family, including many other high-ranking visitors, have stayed for brief periods at Government House

IV. Staff Report

With major recruitments carried out in 2014, where there were seven promotions and 23 new appointments, there was minimal staff movement and recruitment in 2015.

Towards the end of 2015, three staff members resigned and there was one vacant unestablished post which was for a matanivanua. The Office had 90% staffing strength.

Trainings/Workshop

- 1. Two in-house training for Customer Services and Service Excellence Awards Awareness were carried out during the first quarter for all staff members.
- 2. There were 32 different workshops carried out during the year with an average of four workshops per staff member.
- 3. Workshops ranged from Communications, Analysis, Leadership and Protocol, Finance, Domestic and Mechanic training.

4. The trainings were aimed at enhancing the knowledge and skills of members of the staff.



INDEPENDENT AUDITOR'S REPORT

Scope

I have audited the special purpose financial statements which have been prepared under the cash basis of accounting and notes 1 to 3, thereon of the Office of the President for the year ended 31 December 2015. The financial statements comprise the following:

- (i) Statement of Receipts and Expenditure;
- (ii) Appropriation Statement; and
- (iii) Statement of Losses;

The Office of the President is responsible for the preparation and presentation of the special purpose financial statements and the information contained therein.

My responsibility is to express an opinion on these special purpose financial statements based on my audit.

My audit was conducted in accordance with the International Standards on Auditing to provide reasonable assurance as to whether the special purpose financial statements are free of material misstatements. My audit procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the special purpose financial statements and evaluation of accounting policies. These procedures have been undertaken to form an opinion as to whether, in all material respects, the special purpose financial statements are fairly stated and in accordance with government policies stated in Note 2, the Audit Act and the Financial Management Act, so as to present a view which is consistent with my understanding of the financial performance of the Office of the President for the year ended 31 December 2015.

The audit opinion expressed in this report has been formed on the above basis.

Basis of Qualified Opinion

Travel advances totalling \$776,850 was not reconciled and journalized to the relevant expenditure allocations during the year. Consequently, total expenditure is understated by \$776,850 in the Statement of Receipts and Expenditure.

Audit Opinion

In my opinion, except for the matters referred in the qualification paragraph:

- a) The financial statements present fairly, in accordance with the accounting policies stated in Note 2, the financial performance of the Office of the President for the year ended 31 December 2015.
- b) The financial statements give the information required by the Financial Management Act 2004 in the manner so required.

Without further qualifying the opinion expressed above, attention is drawn to the following matter:

Emphasis of Matter - Statement of Losses

The board of survey report for the second half of the financial year was not completed by the Office of the President which may possibly impact the accuracy and completeness of the Statement of Losses submitted for the year ended 31 December 2015.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2015

NOTE 1: REPORTING ENTITY

The Office of the President provides the necessary assistant support to His Excellency, the President in the performance of constitutional functions. The President is vested with the Executive Authority of the State and is the Commander-in-Chief of the Republic of Fiji Military Forces and the Chancellor of the Order of Fiji. In addition to the constitutional and ceremonial roles, the office plays a symbolic role in the promotion of national reconciliation to bring unity among the different ethnic groups in Fiji. The targeted outcome(s) and output(s) in relation to the above responsibilities are illustrated below:

Constitutional Functions

· Prompt and effective facilitation of the Presidents Constitutional functions

International Relations

 Prompt and effective facilitation of support services to strengthen International and diplomatic relations

Public Sector Reform

- · Portfolio Leadership Policy Advice and Secretariat Support

NOTE 2: STATEMENT OF ACCOUNTING POLICIES

(a) Basis of Accounting

In accordance with Government accounting policies, the financial statements of the Office the President is prepared on cash basis of accounting. All payments related to purchases of fixed assets have been expensed.

The financial statements are presented in accordance with the Financial Management Act and the requirements of Section 71 (1) of the Finance Instruction 2010. The preparation and presentation of a Statement of Assets and Liabilities is not required under the current Government policies, except for that of the Trade and Manufacturing Accounts.

(b) Accounting for Value Added Tax (VAT)

All income and expenses are VAT exclusive. The Office on a monthly basis takes out VAT output on total money received for expenditure from Ministry of Finance. VAT input on the other hand is claimed on payments made to the suppliers and the sub-contractors for expenses incurred.

The VAT payment as per the statement of receipts and expenditure relates to the VAT input claimed on payments made to the suppliers and sub-contractors for expenses incurred and VAT payments to Fiji Revenue & Customs Authority (FRCA). Actual amount paid to FRCA during the year represent the difference between VAT Output and VAT Input.

NOTE 3: SIGNIFICANT VARIATIONS

- a.) Increase in the miscellaneous revenue of \$1,416 or 100% in 2015 compared to 2014. These are commission receive from various agencies for facilitating staff deductions which used to be collected and receipted by Prime Ministers Office.
- b.) The Established staff costs increased by \$114,639 or 21% in 2015 compared to 2014. This was attributed to the increase in number of confirmed salary staff due to the recruitment to fill all the vacant established post in 2015.
- c.) The Travel and Communication costs decreased by \$354,822 or 49% in 2015 compared to 2014. This was mainly due to the decrease in the number of overseas official engagements for His Excellency the President as compared to 2014.
- d.) The Maintenance and Operations costs increased by \$263,904 in 2015 compared to 2014. This was attributed to the increase in fuel expenses due to the inclusion of three new fleets in 2015 and the increase in local official engagements of his Excellency the President.
- e.) The Purchase of Goods and Services costs increased by \$27,689 or 19% in 2015 compared to 2014. This was mainly due to the inclusion of a new training vote and the increase in Medical expenses that was fully utilised by His Excellency the President on his Medical trip to Thailand in 2015.
- f.) The Capital Construction costs increased by \$944,764 in 2015 compared to 2014. This was mainly due to the commencement of three projects namely, Coronation Ground Drainage Phase 2, Upgrade of Government House Roofing and Disability Access at the State House.
- g.) The Capital Purchase costs incurred in 2015 was \$157,999 when compared to the nil costs incurred in 2014. This was mainly due to the procurement of a new tractor & a trailer, protective clothing for landscape officers, purchase of ride on mowers brush cutters, chainsaws and other tools vital for the upkeep of the State House grounds and office.
- h.) The expenditure on Value Added Tax increased by \$115,121 or 44% in 2015 compared to 2014. This was due to the increase in expenditures incurred in 2015 as compared to 2014.
